STATE OF HAWAII NOTICE OF PUBLIC HEARING ON PROPOSED AMENDMENTS OF ADMINISTRATIVE RULES CHAPTER 3-70

Pursuant to the provisions of Chapters 91 and 109, Hawaii Revised Statutes (HRS), a notice is hereby given that the Stadium Authority (Authority) will hold a public hearing on October 21, 2015, at 6:30 P.M., Aloha Stadium Hospitality Room, Aloha Stadium, 99-500 Salt Lake, Boulevard, Honolulu, HI 96818, where interested persons may be heard on the proposed amendments described below.

A proposed amendment to Section 3-70-11 would clarify rental charge language; eliminate and consolidate rental categories; increase rental of the facility and parking areas for certain events from \$2,000 to \$2,500 per date or ten percent of gross ticket receipts per date; increase rental of the facility and parking areas from \$750 to \$1,000 per date; increase rental of parking areas from \$1,250 to \$3,000 per date for carnivals, fairs and similar events; add a new subsection for rental of the facility that would provide a rental rate for Charitable, religious and other events or activities of \$2,500 or ten percent of gross ticket receipts per date; add a new subsection for rental of the facility and parking areas that would provide a rental rate of \$500 per hour for Commercial media and \$250 per hour for non-commercial media.

A proposed amendment to Section 3-70-20 would increase parking rate for all events and shows, including when the athletes or performers attend high school or lower grade levels from \$3 to \$7 per event per automobile; increase the parking rate for professional sports events and concerts, excluding Hawaiian cultural and music events from \$10 to \$15 per event per automobile; add a new subsection which would allow the manager to have the authority to sell bulk parking, in whole or in part, to a licensee at a rate not less than the published rate for the contracted event or activity; and add language to exempt private events held in the Hospitality Room from the subsection.

All interested persons shall be afforded an opportunity to submit data, views, or arguments at the time of the hearing, orally or in writing. Persons who wish to testify are requested to submit ten (10) copies of their written statement.
