CALL TO ORDER

Kristen Ribilla, Notary Public, was present to witness the swearing-in. The Chair informed everyone that Hubert P. Minn, also a newly appointed board member, was sworn in by Deputy Attorney General Randall Nishiyama on June 20, 2018. Member Minn will be attending the July meeting.

(8:43 a.m.) The Chair announced that Charles T. Toguchi, the Stadium Authority's long-standing member, is attending his last meeting today as a Stadium Authority member. We are very sad to see him go and are presenting him with a small token of our appreciation for all that he has contributed to the Authority. Manager Scott Chan added, we at the stadium could not have come as far as we have without the guidance and strong leadership from Member Toguchi, for which we are truly grateful. On behalf of the Stadium Administration and the Stadium Authority we thank you very much for the service that you provided.

(8:44 a.m.) Member Toguchi expressed his appreciation to everyone. He said we have an outstanding board under the leadership of Chair Yamasaki with young people that can really contribute a lot -- especially as we move into the important part of the stadium's development plans. He thanked the Governor, Chair Yamasaki and the Board for the opportunity given to him. He also thanked Manager Chan and said it's been great working with him and that he has the greatest respect for all the work that the stadium staff does, which has been a learning lesson for him.

IV. Monthly Reports

A. (8:47 a.m.) Chairman's Report

The Chair said today's agenda will be quick. There will be one item under "new business" regarding the stadium manager's evaluation.

Bruno Mars Ticket Sales

The Chair took the time to recognize stadium management and staff with regard to the Bruno Mars ticket sales. Although he was away during the first weekend of ticket sales, he heard nothing but positive comments from friends who participated in the lines.

Once the second concert was announced, the anticipation and experience was different due to some of the emotional responses by the fans with regard to accessing tickets. The attitudes changed and the line outside the stadium property started early during the weekday. Management did notify the proper authorities to discourage the line but to no avail. For the most part customers were appreciative with the accommodations within the concourse, and being sheltered from the rain with access to restrooms and concessions that were provided overnight prior to tickets sales at 10:00 a.m. the next day. That evening the Chair was there from 8:00 p.m. to 12:30 a.m. walking outside and interfacing with our customers and reminding them that management was doing all of this as a courtesy -- allowing the community the opportunity to purchase tickets at face value without the transaction fees. The Chair added, all that was provided was the result of management's initiative to try and best serve our customers in support of the Authority's mission to service our community.

They did service close to a thousand people. Manager Chan did very well as the Chair watched him walk the line and answer almost any question that the customers had for him that evening over and over again, (even if they were on the frequently-asked-questions [FAQ] sheets that were passed out). The Chair said he just wanted to recognize the stadium and the staff who took it upon themselves to represent the stadium and stadium authority. It is really appreciated - thank you very much.

B. (8:52 a.m.) Stadium Manager's Report (attached)

Manager Scott Chan stated the following (in addition to his attached report):

1. We met with the administration to discuss the impact of HB1900 regarding the overall budget and the direct impact it has to our program. We unfortunately

lost two full-time positions and one temporary employment position; and we did not receive Health & Safety (H&S) and Capital Improvement Project (CIP) funding for a second year. On the positive side, requests for funding can be made in the next year or two. We are optimistic about the future and continue to work towards accomplishing our set goals.

2. Bruno Mars Ticket Sales - Manager Chan said the comments by the Chair regarding the Bruno Mars ticket sales are greatly appreciated. He stated he couldn't have been surrounded by a better group of individuals (his staff) and is so proud of them for their outstanding effort. He also thanked the board for supporting the decisions that management made. Due to unruly behavior by certain individuals, he informed the board that he nearly cancelled ticket sales and made it very clear that he would not compromise public safety, which at one point was of great concern.

In addition to the very good evaluation provided by the Chair, Manager Chan shared a slide show for the board's information of the activities that took place prior to/and leading up to the day of the ticket sales:

- To relieve the pressure at the front of the line, they allowed the customers Access downstairs to camp out the day before ticket sales -- in the hallways and corridors in front of the stadium's administration offices. It was a challenge to try to get people to move, because they all gathered to the front of the line and would not relinquish their positions. As we tried to push back the crowd, it created other issues where people were cutting in line (in the gaps where people were not moving fast enough). It was total chaos, with people swearing, pushing, etc. However, his staff kept calm and handled the situation well.
- To add a special touch, for which we are very grateful, (upon request) Davy Murayama (of Centerplate) provided freshly baked cookies which we were able to pass out to our customers. It helped to ease the anxiety of the crowd which was evident prior to the opening of the box office windows.
 Customers were very appreciative.
- After Management made the decision to close turnstile Gate 3 (after reaching a threshold of what was manageable to best serve the public and over the course of the day), the line outside the gate grew well over several hundred people. (The Chair added that the Manager based his decision by determining what took place at the previous sale, i.e., the length of the line

and the likelihood of being able to purchase tickets). Although the chances were slim for those in line, Manager Chan said, fortunately, we were able to accommodate them.

- Manager Chan said the decision to call a press conference immediately after we allowed the public access into the stadium on Friday, was for the public to hear our side of the story (the challenges we were faced with) and to answer their tough questions. We hope we represented everyone well by doing that.
- During this time we also had three other events going on -- 50th St. Fair, i9 Sports and the Swap Meet.
- On the day of the sale, our staff had complete control of the lines at the box office -- all questions were being answered and the lines moved quickly.
 Tickets were sold out in two hours for the first sale and approximately an hour and a half longer for the second sale. The radio stations provided entertainment (fronting the box office). We are pleased that the promoters (Live Nation) worked well with us to allow us to accommodate everyone that was in line.
- Manager Chan thanked everyone for their support. He said these are times when you test your will (and who is really on your team) to get what needs to be done and be an actual team player and achieve the success that we did, because we couldn't have done it without the cooperation of everyone.

Manager Chan said the stadium is holding a job fair to address the hiring for the 2018 football season in the Hospitality Room June 29 & 30 from 10:00 a.m. to 2:00 p.m. We are falling short of our manpower and are making every effort to increase our recruitment for the upcoming season. Last year was a challenge and we look forward to an exciting year with increased attendance

The Chair said it's in the news (and all over) that it is a challenge with the low unemployment rate and job market competition -- appreciate your efforts.

He added, we can all acknowledge that the BM concert is a novelty (you can't find 5 or 10 other acts where this type of thing might happen -- you might find one or two down the road but Manager Chan and staff did an incredible job not having had a huge amount of experience with this type of thing and especially since this thing happened twice.
