 - 1. Stadium Financial Update:

Administrative Services Officer (ASO) Russell Uchida reported: See Exhibit A Discussion:

- Member Fink stated the \$71K shortfall at the end of the year assumes that the projected numbers for the swap meet are being used. He proposed if the swap meet continues to show growth, then it is possible that the negative amount would be eliminated.
 - Mr. Uchida agreed with Mr. Fink.
- Member Abe wanted to know where the special events are reflected in the spread sheet.
 - Mr. Uchida responded that they are listed as two revenue components under Food & Beverage and Rent.
 - Member Abe suggested there should be a "special events revenue" line item to see how well the special events are doing.

Mr. Uchida explained that this report aligns with the state's database system, and licensee events are charged rent and it's recorded accordingly.

Member Abe suggested to notate the revenue since an event happened in December and it was not recorded until February. This would enable us to see the impact and source of revenue.

Mr. Uchida responded that he would discuss with Manager Chan to create a separate sheet that summarizes the various events.

 Ms. Spain responded with the following:

- i. Advertising This will be promoted as a fourth day of the swap meet.
 Avenues considered for advertisement are T.V., print, radio [possibly i-Heart radio], social media, and a press release.
- ii. Seating In 7D there are currently benches and we are working on a layout for more seating while adhering to socially distant guidelines.
- iii. Liquor We are currently unable to serve liquor due to the pandemic guidelines. We are considering a beer garden once we can safely do so in tier 4.

 - i. Establishes the stadium development district and gives full oversight to the Stadium Authority (SA) over the project.
 - ii. Provides two new members on the Stadium Authority Board from the community.
 - iii. Provides the SA to have title to the land.
 - iv. Provides a ninety-nine-year lease.
- b. SB1033
 - i. \$1.5M emergency appropriation to address financial shortfall for FY21.
 - ii. This bill moves over to Ways and Means.

Senator Misalucha commented by providing positive feedback in support of the NASED project and encouraged the stadium to partner with UH.
