I. CALL TO ORDER

A quorum being present, Chair Yamasaki called the meeting to order at 8:32 a.m.

III. <u>APPROVAL OF MINUTES</u>

- A. Approval of minutes for the following date:
 - 1. Regular Session August 26, 2021

A MOTION WAS MADE BY MEMBER IOSUA AND SECONDED BY MEMBER FINK TO ACCEPT THE MINUTES OF THE REGULAR SESSION. THE MOTION WAS UNANIMOUSLY CARRIED.

IV. MONTHLY REPORTS

A. Chairman's Report – Chair Yamasaki stated that the board's focus remains on operations within the COVID-19 environment and the New Aloha Entertainment District (NASED). Chair also stated that he received a notice from Manager Chan, and he asked Manager Chan to address the notice.

Manager Chan made the following statement:

It has been a pleasure and honor to serve the state of Hawaii for nearly 40 years, the last 25 years under the administrative guidance of the Aloha Stadium Authority. I am grateful for the time spent at Aloha Stadium and the tremendous support over the many years by the Administration, Legislators, Stadium Authority, Department of Accounting and General Services, Clients, and finally the Stadium Administrative team.

Therefore, I have decided it is time for the next generation of outstanding leaders to carry on and fulfill our mission and I am announcing my retirement.

Although there is still much to do, rest assured we have been preparing staff for several years to ensure a smooth transition. It has been a joy and pleasure to work with all of you and I am confident that this team is capable of finishing what we started.

Manager Chan went on to thank Chair Yamasaki and all that he has learned under his leadership. He also thanked Deputy AG Nishiyama for being a tremendous resource over the years.

Comptroller Otaguro stated that Manager Chan has exemplified stability, professionalism, and commitment. The state and stadium have been fortunate to have Manager Chan's leadership providing significant innovation in an aging stadium. On behalf of Governor Ige and the Administration, Comptroller Otaguro thanked Manager Chan for his 39 years of dedication to the State of Hawaii.

Manager Chan thanked Comptroller and DAGS Administration as well as Public Works Administrator, Chris Kinimaka for their years of support.

Chair Yamasaki presented him with a certificate of service on behalf of the Comptroller and made the following statement:

We appreciate all of Mr. Chan's work and dedication he has put into the stadium. His career has come full circle from once playing high school football in the newly developed Aloha Stadium to now paving the way for a new era with the New Aloha Stadium Entertainment District. We will truly miss Scott and thank him for all his hard work and leadership.

Lastly, Manager Chan requested that Mr. Ryan Andrews, Stadium Deputy Manager, take his seat to complete the rest of the agenda as Interim Manager.

B. Stadium Manager's Report - Attached

Interim Manager Andrews congratulated Manager Chan on his retirement. He added that Manager Chan has been at the helm during some of the most challenging and best times that the stadium has ever had. He also expressed his gratitude for Manager Chan's mentorship he's provided over the last five years.

- 2. Interim Manager Andrews added the following:
 Last month Manager Chan announced that the Swap Meet contract was
 expiring at the end of August and that we were working on a Revocable Permit
 for Centerplate to continue management services for the Swap Meet.
 - a. First, the update is that the Revocable Permit was signed and went into effect on September 1st.
 - b. Although the Swap Meet contract ended on August 31st, the contract did allow for two additional contract extensions of up to two years each. Extending the contract was our preferred action, however, the contract included a minimum revenue target, and given our current business climate with COVID-19 and mitigations in place that reduce the size and scope of the market, hitting that target is not realistic for Centerplate.
 - c. Further complicating this point is that with development on this property likely in the coming year, the swap meet must relocate some or all of its

- operations to a different location on our property. The exact details about the future location will not be known until the RFP process is complete. Without knowing the specific location and more importantly the size of the available space, it's impossible for Centerplate to commit to any established revenue goal or even to project revenue.
- d. Knowing that the terms of the existing contract would not work for Centerplate, we did consider going back out and doing an Invitation for Bids, but given what I just explained, it's impossible for any entity to project or guarantee revenue without knowing what resources are made available to them.

For those reasons, we opted for a short-term solution, which is the Revocable Permit. This is essentially a month to month arrangement that can extend for up to 1 year.

The details of the Revocable Permit are very similar to the prior contract, however, one of the key changes in this permit is that the stadium staff is managing the parking and entrance areas and Centerplate remains managing the actual marketplace, all stall sales and vendor relations.

Current Events:

- Continued COVID-19 testing and vaccinations on property through the Department of Emergency Management testing and vaccinations will continue through the end of October.
- Habilitat's Drive Thru Haunted House in our Lower Halawa Parking Lot from October 8th 31st.
- The Christmas Lights show will set up in the lower lot following Halloween.

Chair Yamasaki asked if these events are compliant with the COVID-19 guidelines since they were events that were held in 2020. Interim Manager Andrews confirmed all events are in complete compliance.
