MONTHLY SECURITY REPORT TO THE BOARD

Summary of security related incidents which occurred September 1, 2023, through September 30, 2023.

Theft (4 face masks & 1 ski mask)

On September 3, 2023, at approximately 12:45 p.m., Swap Meet Vendor reported theft of four face masks and one ski mask. Vendor was helping one Micronesian teenager, then saw two other Micronesian teenagers grab masks and run away. Teenager who was talking with Swap Meet Vendor also ran away. Total Value of five masks was \$25.00. Swap Meet Vendor declined to call Honolulu Police Department (HPD) and file an HPD Report.

Trespass Warning

On September 10, 2023, at approximately 06:30 a.m., female was stopped by Centerplate Staff with two rolls of toilet paper, taken from Gate 4 Parking Lot Restroom. Restroom areas were being monitored by Centerplate Staff, because of multiple thefts of toilet paper. Trespass Warnings were issued by Centerplate and Aloha Stadium, for periods of one year each.

Motor Vehicle Collision (MVC)

No one at Swap Meet recognized elderly male person. HPD was called and eventually, HPD was able to contact a family member. Elderly male was picked up at about 1:00 p.m.

Three Medical Assistance Calls were reported; all were Injured Cared For (ICF). Two cases were Trip & Fall; in one case, Injured Person was evaluated & treated by Stadium Nurse, but declined call to Emergency Medical Services (EMS). Injured person's family member agreed to transport injured person to Emergency Room for further medical evaluation & treatment. In one case, injured person was evaluated & treated by Stadium Nurse, then injured person's family member requested EMS assistance and transport via ambulance to Emergency Room. EMS arrived, evaluated & treated injured person, then transported to Emergency Room via ambulance.

In one case, injured person was evaluated & treated by Stadium Nurse, but refused call to Emergency Medical Services (EMS). Injured person was released to family member
