#### MONTHLY SECURITY REPORT TO THE BOARD

Summary of security related incidents which occurred June 1, 2024, through June 30, 2024.

#### Unauthorized Entry Into Motor Vehicle (UEMV)

On June 2, 2024, during Swap Meet, a customer's rental vehicle was broken into. A backpack and cotton bag were taken from inside their vehicle. Honolulu Police Department (HPD) responded and an HPD Report was Filed.

### Motor Vehicle Collision (MVC)

On June 9, 2024, a Tent Vendor's employee ran into a Swap Meet Vendor's tent, damaging tent's poles and hardware. No HPD Report was filed. No injuries were reported.

On June 19, 2024, during Swap Meet, a motor vehicle collision involving two customers. HPD responded and an HPD Report was filed. One vehicle could not drive after collision and was left overnight. This vehicle was towed away the next day.

#### Vendor Tarp Flew Over Adjacent Vendor Tent

On June 8, 2024, a Swap Meet Vendor's Tarp blew off and flew over adjacent Swap meet Vendor's Tent. No injuries were reported.

#### Medical Assistance during Swap Meet

Stadium Nurses reported Eleven Medical Assistance calls during June 2024. Six calls were Injured Cared For (ICF); three ICFs were Trip & Fall.

One case, customer tripped & fell when they stepped on some rocks and uneven pavement. Stadium security transported customer to First Aid Station. Stadium Nurse evaluated & provided medical aid to customer. Customer was released on their own.

Second case, customer tripped & fell on uneven pavement. Stadium Nurse evaluated & provided medical aid to customer. Nurse encouraged customer to have ambulance transport to Emergency Room. Customer refused Emergency Medical Services (EMS) and stated they would drive themselves to Emergency Room. Customer was released on their own.

Third case, customer tripped & fell over a bump/curb in parking lot. Customer complained oldage customers have hard time lifting leg over bumps/curb. Stadium Nurse evaluated & provided medical aid to customer. Customer was released on their own.

Fourth case, customer felt weakness and their leg gave out. Stadium Nurse evaluated & provided medical aid to customer. Customer declined further medical treatment and was released on their own. Stadium Security transported customer to their car.

Fifth case, gust of wind blew customer's hat off their head and customer fell backwards while trying to catch their hat. Stadium Nurse and EMS evaluated and provided medical aid. Customer was transported by EMS to Emergency Room.

#### Medical Assistance during Swap Meet (continued)

Injured Cared For, sixth case, Swap Meet Vendor fell while setting up their Vendor tent early in morning. Later in morning, this Vendor went to First Aid Station. Stadium Nurse evaluated & provided medical aid to customer. Customer was released on their own.

Five cases were Sick Cared For (SCF).

One case, customer wasn't feeling well and had a seizure. Stadium Nurse and Emergency Medical Services (EMS) evaluated and provided medical aid. Customer was transported by EMS to Emergency Room.

Second case, customer felt dizzy and sat down in shade. Customer called 911. Stadium Nurse & EMS evaluated & provided medical aid to customer. Customer was stable after treatment and was released on their own. Stadium Security transported customer to Main Parking Gate. Third case, customer wasn't feeling well and was nauseous. Stadium Nurse evaluated & provided medical aid to customer. Customer was released on their own and stated they would drive to Urgent Care for further medical assessment.

Fourth case, customer felt dizzy and fainted. Stadium Nurse and Emergency Medical Services (EMS) evaluated and provided medical aid. Customer was transported by EMS to Emergency Room.

Fifth case, customer fainted and was caught by family member. Stadium Nurse evaluated & provided medical aid to customer. Customer was released to their family member.
