I. <u>CALL TO ORDER</u>

A quorum being present, Chair Morioka called the meeting to order at 8:00 a.m.

- A. Stadium Manager's Report and Operational Reports
 - 1. Monthly Financial Update
 August ended with a surplus of \$155.2K, a net cash balance of \$55.3M, and a projected carryover cash balance of \$56.5M for FY26. (Exhibit B)
 - 2. Operational Updates and Announcements
 - a. Annual Audit:

The audit of our financial statements as of June 30, 2024 has commenced. The scope of this year's audit is like past years and expected to be completed by the end of November. Manager Andrews will provide an update when the report is ready for review.

b. Events:

- Hawaii Construction Career Day September 19th 20th Hundreds of middle schoolers and high schoolers were on site being introduced to the various trades and future opportunities in construction. It's possible that these students could work in construction on the stadium district for years to come.
- Megabon September 7th.
 - o Estimated attendance of about 15,000.
 - This event partnered with the Department of Transportation Services (DTS) to extend the hours of the Skyline operations with about 4,000 riders (about double the average ridership).
 - o There was positive feedback with the expanded layout of the event.
 - Lighting in the dance area will be improved in the future.
 - This event included a drone show, which was a very popular addition to the event.

- C. New Aloha Stadium Entertainment District (NASED) Committee Report Deputy Manager Sadayasu provided an update:
 - The evaluation process continues, and the committee is ensuring that the best value for the state exists. There are no current announcements yet until the committee completes its process.
 - Chair Morioka and Member Pereira were featured on the Rick Hamada show this past month which was a good segment as well as Let's Talk Sports and KHON2 News.
 - The team did a presentation to the Construction Management Association of America/Hawaii Chapter which was well received.

Discussion

Member Pereira asked (for the benefit of the public) for a recap on how the scoring takes place since it's a very thorough process with benchmarks that the proposer must meet.

Manager Andrews responded that there is a five-member committee that has been appointed by the State Comptroller. The committee comprises a mix of state employees as well as individuals with development expertise. They are looking at all parameters of the proposal, which includes an administrative proposal, a technical proposal, a financial proposal, a diligence and discussion proposal, and statements of commitment. Manager Andrews shared that this is not just a stadium project, and this evaluation also looks at how the developer will build out and finance the entire district, which includes retail, housing and even hotels and is likely to be built in phases over the next two decades. For the stadium alone, they need to ensure the developer is proposing the overall scope requirements such as capacity, number of locker rooms, number of suites, etc. This is an extremely detailed process that requires technical advisors who support the evaluation team. Should the developer be advanced as the Preferred Offeror, we will then enter a diligence and discussion period where the developer will perform site diligence, inclusive of geotechnical and hazardous materials studies, as well as negotiate the finer details of a contract.

Deputy Manager Sadayasu added that the project team, evaluation committee and technical advisors have been meeting with Aloha Halawa District Partners (ADHP) weekly. The team also issued a Request for Clarifications (RFC) and they are going through the detailed response as well as the scoring, evaluation and recommendation to the Comptroller.

Member Pereira concluded that it is good for the public to hear how detailed of a process this is and how thorough the NASED team is being to ensure the tax payers get the most value for what will be a live, work, play, thrive community.
