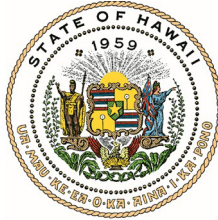

    - HB1800 – RELATING TO THE STATE BUDGET - Adjusts and requests appropriations for fiscal biennium 2025-2027 funding requirements for operations and capital improvement projects of Executive Branch agencies and programs.
    - SB2599 - RELATING TO DEVELOPMENT - PART I: Redesignates the Stadium Development District as the Halawa Community Development District (HCDD). Amends the composition of the Hawai'i Community Development Authority (HCDA) for purposes of the HCDD. Amends the duties and powers of the HCDA and Stadium Authority as they relate to activities within the HCDD. Clarifies the HCDA's permitting and consultation powers regarding public projects within community development districts. Establishes the HCDD Special Fund. Appropriates funds. PART II: Appropriates funds from the Stadium Development Special Fund for the planning, design, and development of the HCDD, contingent upon on certain requirements. PART III: Requires the HCDA, when planning and developing housing, to endeavor to plan for complete communities that include various aspects supporting quality of life.
    - SB2074 – RELATING TO STATE FACILITIES - Exempts concessions within the Stadium Facility that are under the jurisdiction of the Stadium Authority from chapter 102, HRS. Allows the naming rights of the Stadium Facility to

be leased to any public or private entity. Requires any revenue derived from advertising or marketing in or on the Stadium Facility to be deposited into the Stadium Development Special Fund.

- SB 2353 - RELATING TO OUTDOOR SIGNAGE - Allows the display of outdoor advertising devices, including digital outdoor signage devices, within the Stadium Development District with the authorization of the Stadium Authority and subject to certain conditions. Requires the Department of Business, Economic Development, and Tourism to conduct a study on the impacts of light pollution associated with the devices and report to the Legislature.
